A transformational accompaniment

The most important information to sum up the activity of ABD is the overview of the meticulous work that has taken place, which is closer to craftsmanship than it is to large gestures. ABD is able to reach a large number of people who, for many reasons, find themselves in a situation of **social vulnerability**. But what these large numbers do not show is how the **accompaniment process** that we offer each day is carried out: the time dedicated to listening, to creating links, to building, to taking pauses or for starting over again. Today, providing space and time for social intervention is a necessary concession that directly affects those who benefit from our actions. Because it is only through this intervention that we can achieve the **commitment, involvement and social transformation** that, as an entity, we need.

For this reason, we wanted to present an overview of our actions in the framework of the Social Intervention Model that we advocate: no matter how individualised our intervention is, it always has an effect on the community because **we defend people's rights** and involve other players, and on the other hand, **our participation in the community to develop public policies** that are more fair and equal, has an effect on individual improvement processes.

This global intervention model, and our unwavering conviction that services devoted to people should not be for the purpose of making a profit, is what encourages us **to keep constructing an organisation that aims to be instrumental in building a society that does not exclude anybody.**

Impact 2016

Social intervention brings about changes

#ImpactELDERLYPEOPLE *We have managed to curb the isolation of elderly people by **92%**, who we assist daily with activities and meeting spaces.*

#ImpactWORK ***50%** of people who use integration services find work despite a lack of work experience and the lack of opportunities on today's job market.*

#ImpactFUELPOVERTY *We have managed to save the equivalent amount of energy to power **220 homes** for a year, therefore increasing families' social wellbeing and health.*

#ImpactGENDEREQUALITY *Over **65%** of children think that girls can be brave and adventurous and that boys can be caring, after attending gender equality workshops in schools.*

#ImpactDRUGS *We have announced **84 alerts** via the Drug Analysis Service, providing information on new psychoactive substances and more toxic adulterants, achieving a global impact on the health of people who consume synthetic drugs.*

#ImpactPREVENTION *Because we have to address the root causes, **13,600 people** attended workshops on drug prevention, gender equality, fair treatment, intercultural awareness, emotional and sexual health and energy efficiency, particularly children and young people.*

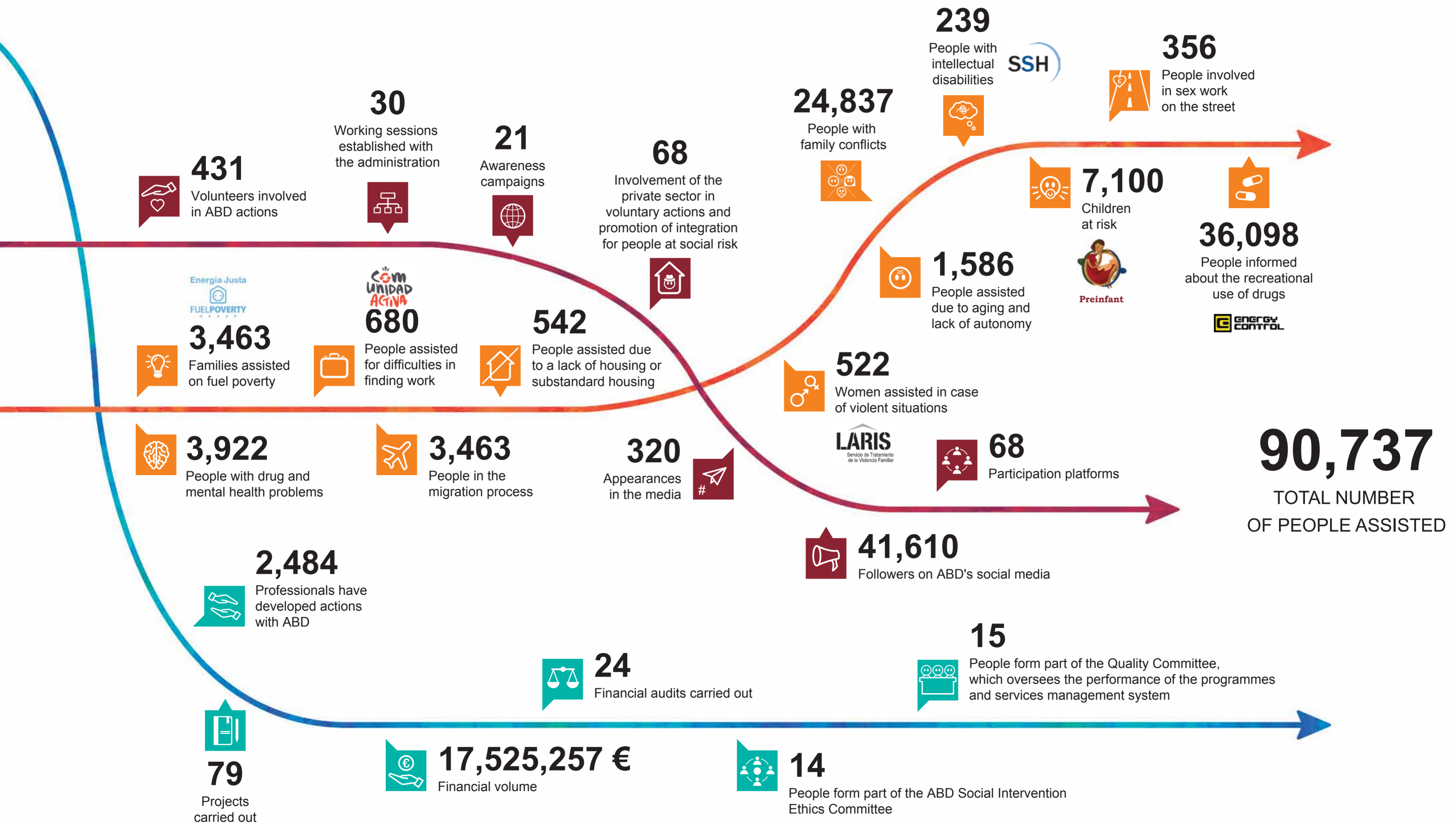
